The Brides, and two parents copy tapes are included in the package price. *All additional tapes are \$30.00 each. Additional Copy Costs are not included in the "Total", item # 14 above.*

PLEASE DELIVER \$ _____, an Invitation, Hall Card, Napkin, 20 Photos of the bride, 20 Photos of the groom, (baby through teens), and 10 Photos as a couple and CDs and or audio tapes if selected. Personal background music if selected 'must' arrive with the pictures or we will select music from our collection. Separate the pictures into 3 envelopes. Number the back of each picture in age sequence. Draw a map to the house, church and hall. Deliver all of the above no later than 2 weeks before your wedding. We will give you a reminder call 4 weeks prior to your wedding. Include date of wedding and grooms name. Due to full days coverage, usually including some special footage surrounding the dinner activities the Videographer does join guests for dinner.

1. Swensen's Wedding Videos: **Commits to supply a camera person of their choice who assumes the responsibility to endeavor diligently and to the best of their creative and skilled ability to capture on video tape the important and momentous highlights of the specified day; Commits to supply highly reliable and quality equipment for every anticipated situation including but not limited to a back up camera while retaining the sole discretion to select the type, brand, model and compliment of all video and associated equipment as is necessary, appropriate and required for the days activities; Commits to use nonintrusive lighting on immediate subjects when determined by the videographer that such is appropriate; & Commits to promptly extend every reasonable and appropriate effort to overcome any and all impediments, situations and or negative contributors to the content and quality of the final product.**
2. Understanding that the final video reproduction is the outcome of a one chance filming of the events of the moment Swensen's Wedding Videos and the undersigned agree that the following negative contributors are beyond the control and that the consequences of such are not the responsibility of Swensen's Wedding Videos Rules, regulations and associated matters within the control of the Church or the Marriage Facility and or the Hall or the Reception Facility; **Unaware or ill-mannered guests, attendees or hired service people who inhibit, prevent or prohibit the video recording of favored activities or events; Natural or artificial lighting conditions of the filming environment; Background noise or audio interference that prevents or inhibits a clear reproduction of the immediate subject; Electronic and or other interference that prevents or inhibits a clear reproduction of the marriage vows and or other transmissions. The undersigned further understands and agrees that Swensen's Wedding Videos is in "NO WAY" responsible or liable for such negative contributors and accepts as is any and all consequences included but not limited to deficiencies in the reproductions.**
3. Swensen's Wedding Videos and the undersigned agree that all additional video reproductions will be distributed solely by and through the undersigned who accepts full responsibility for payment. Orders received from any other parties are for consideration only. Final determination is dependent upon the agreement of Swensen's Wedding Videos and the undersigned. Notwithstanding the above the undersigned agrees to the use of reproductions of selective footage of the subject taping for the promotion and advertisement of Swensen's Wedding Videos.
4. Swensen's Wedding Videos and the undersigned agree that cancellations must be received by Swensen's Wedding Videos in writing at least 90 days prior to the scheduled wedding date. Non complying cancellations do not absolve the undersigned from their obligation for full and prompt payment.
5. Swensen's Wedding Videos and the undersigned agree that this is a contract for the sale of goods, that the goods are the video tapes that are to be delivered to the undersigned, that the labor expended to capture the content of the video tapes is incidental to the contract and that the contract is regulated by the UCC as modified and incorporated into MCLA, Sections 440, and that said sections are hereby incorporated by reference into this contract in their entirety.
6. Swensen's Wedding Videos and the undersigned agree that this written contract constitutes the entire agreement between the parties and that there are no representations or warranties, express or implied other than those expressly written or referenced herein, that seller makes no warranty as to the quality of the final product, that seller's warranty is limited to a warranty of their aforementioned commitment to endeavor diligently so as to create the best video reproduction possible and that any and all subsequent modifications to this contract must be in writing and signed by all the original parties, it being understood that this contract and or any rights thereto are not assignable or transferable.
7. **LIMITED LIABILITY:** The undersigned agree that any and all actions for damages by the undersigned of any kind whatsoever including but not limited to breach of contract, equipment failure and or negligent acts of, by or through Swensen's Wedding Videos, including but not limited to its employees, associates, helpers and or camera person or persons, is **LIMITED TO A FULL REFUND OF THE "PRICE", (as recorded in line # 14 above), MINUS THE NONREFUNDABLE "RETAINER"**.
